Preface

Multiple sclerosis is a lifelong, potentially disabling disease of the central nervous system that affects the white matter tracts of the central nervous system in a sporadic and unpredictable manner. The disease produces inflammation and demyelination of the white matter, as well as varying amounts of damage and destruction to the underlying axon. The onset of disease is most often in early adulthood. Individuals experience a myriad of symptoms with likely progression of disability over time. Symptoms may include fatigue, visual disturbances, sensory changes, incoordination, pain, tremor, elimination dysfunction, and cognitive impairment. Symptoms usually occur as relapses early in the disease, or as symptoms that appear over 24-48 hours and recede to some extent over weeks to months. After a decade or so, many individuals experience fewer relapses, but in their place is a slow progression of MS symptoms that often leads to increased functional disability over time. A small percentage of patients will experience progression from the onset of the disease and experience progressive mobility impairment over time.

MS invades every aspect of life, and patients as well as families can be severely affected. Patients and families experience a sense of loss, both real and perceived. The disease can adversely impact the roles of provider, spouse, parent, friend, and employee. There are emotional consequences of the disease as well as physical ones. As the disease is one for life, individuals and families will have multiple needs throughout their lives. They will need emotional support, education, symptom management, adaptation to changes, adaptive equipment, supportive care, and perhaps even end of life care.

Nursing is a critical element in meeting the multiple needs of the MS patient and family. MS nurses have evolved from home-based care providers giving support to the disabled person to certified MS nurses and advanced practice nurses who must be well educated in the disease process and the available treatments. In addition, MS nurses must be sensitive to and supportive of the emotional needs of those affected by the disease. MS nurses must provide appropriate educa-

tion regarding the disease process, treatment regimes, symptom management, and community resources.

As MS knows few borders, MS nurses are needed throughout the world. Nurses need to share experiences and knowledge to support MS patients and families as well as each other. Through the vision of June Halper, MSCN, ANP, FAAN, the International Organization of Multiple Sclerosis Nurses (IOMSN) was founded in 1997. Its mission is to establish and perpetuate a specialized branch of nursing in multiple sclerosis; to establish standards of nursing care in multiple sclerosis; to support multiple sclerosis nursing research; to educate the healthcare community about the disease; and to disseminate this knowledge throughout the world. The ultimate goal of the IOMSN is to improve the lives of everyone affected by multiple sclerosis through the provision of appropriate healthcare services.

This IOMSN determined that the expertise of the MS nurse needed to be developed and recognized. To that end an international certification board, separate from the IOMSN, was established and a certification process was developed. The first MS nursing certification exam was given on June 5, 2002 in Chicago, Illinois. Over 100 nurses from around the world sat for this exam. Prior to the exam several review courses were held in various locations. It was clear following the review courses that a tremendous amount of knowledge is needed to be an "expert" in MS nursing.

This core curriculum summarizes in outline form the basic concepts of multiple sclerosis and MS nursing. Each chapter provides relevant information as well as references for further study. Readers will learn about the history of MS, as well as the current theories regarding the immunologic basis for the disease. Pharmacologic strategies that include treatment for acute attacks, immunomodulating therapies, and symptomatic therapies are discussed, as are nonpharmacologic interventions.

This text provides the reader with essential information about multiple sclerosis and its management. It is an excellent review for those interested in MS nursing certification, and an excellent resource and reference for the MS nurse. Through the dedicated efforts of June Halper, this core curriculum is available to all of us involved with the care of persons with MS.

Chapter 1

The History of Multiple Sclerosis Care

Objectives:

Upon completion of this chapter, the learner will:

- Identify the evolution of knowledge that has impacted the care of people with multiple sclerosis (MS)
- Discuss turning points in the definition of MS
- Describe the networks in MS care
- Multiple sclerosis (MS) is a common neurologic disease of young adults. It affects people in the prime of their lives with unpredictability and uncertainty.
- In recent decades the hallmark of disease progression has been altered due to disease-modifying therapies for relapsing forms of the disease.
- It has been known as a peculiar disease state (Robert Carswell), a gray degeneration of the cord (Jean Cruveilhier), and insular sclerosis (William Moxon and William Osler).
- Disseminated sclerosis was a term used in the early part of the twentieth century.
- The name "multiple sclerosis" is a derivation from the German "multiple sklerose."
- Early cases were:
 - A. Saint Lidwina van Schiedam
 - B. Halla, the drummer Bock, and William Brown, a Hudson Bay official
 - C. Sir Augustus d'Este
 - D. Heinrich Heine
 - E. Margaret Gatty

- An early monograph on MS was written by Charles Prosper Ollivier.
- Other writings on MS were by Robert Carswell, Jean Cruveilhier, Marshall Hall, and others. These included anatomic depictions of autopsy findings and the description included a clinical history.
- Jean-Martin Charcot framed the disease and thoroughly described the clinical and pathologic features of MS in 1868. He added to the observations of Carswell, Cruveilhier, and the German physician von Frerichs with his own, calling the disease *le sclerose en plaques* or scarring in patches.
- In 1873, Dr. Moxon in England characterized the disease based on observations.
- In 1878, Dr. Ranvier discovered myelin.
- For over 100 years, physicians were frustrated trying to identify the cause of MS. Theories of causation ranged from infection to genetics, vascular problems, and immunologic deficits.
- In 1916, Dr. Dawson at the University of Edinburgh in Scotland used a microscope to describe inflammation around the blood vessels and the damage to the myelin with a clarity and thoroughness that has never been improved. Little was known about the brain's function, so the meaning of these changes was only a guess.
- In 1919, abnormalities in cerebrospinal fluid (CSF) were observed. The significance was unknown.
- In 1925, the first electrical recording of nerve transmission was made by Lord Edgar Douglas Adrian. The science of electrophysiology established techniques needed to study nerves.
- In 1928, myelin was studied under a microscope; oligodendrocytes (cells that produce myelin) were discovered.
- In 1935, Dr. Rivers at the Rockefeller Institute in New York reproduced the autoimmune response classically seen in MS. An animal model for MS was developed called *experimental allergic encephalomyelitis* (EAE).
- Dietary modification was studied with no conclusive evidence of benefit.
- Alternative or complementary therapies emerged as a frequently used supplement or a substitute for conventional treatments.
- In 1946, Sylvia Lawry founded the National Multiple Sclerosis Society in New York City, which has expanded into a worldwide

MS Network of MS Societies. Services and programs include a wide range of patient and family services, basic and psychosocial research, and MS education. NMSS and the Canadian MS Society cover North America with a wide range of programs and services.

- Dr. Kabat at Columbia University received the first NMSS grant to study MS.
- Dr. Salk received an NMSS grant to study the immunology of MS.
- In 1950, NMSS helped to establish a new division of the National Institute of Health (NIH), the National Institute for Neurologic Disorders and Stroke (NINDS).
- In 1967, Ms. Lawry founded the International Federation of MS Societies, now the Multiple Sclerosis International Federation (MSIF).

In 1969, the first successful clinical trial in the treatment of MS was held.

A. Placebo controlled

- B. New rating scales and diagnostic standards used
- C. Patients were given ACTH
- In the 1970s, research produced useful results.
 - A. Scientists studying EAE suspected myelin protein fragments prevented the disease
 - B. A mixture of the fragments was used to treat animals and then humans with MS (copolymer 1)
 - C. Steroids were now widely used to suppress immune response
 - D. In 1978, computed tomography (CAT) scanning was first used for patients with MS
 - E. First experiments with interferons demonstrated their immunemodulating effects
- The 1980s saw the beginnings of major clinical trials in MS using immunomodulators, such as interferons and glatiramer acetate (copolymer 1).
- Dr. Young performed the first magnetic resonance imaging (MRI) on a patient with MS.
- In 1984, it became apparent that MRI can visualize MS attacks in the brain, including many that did not manifest symptoms.
- In 1993, FDA approved Betaseron[®] (IFN-beta 1b) for relapsing remitting MS (R-R MS).

- In 1996, Avonex[®] (IFN-beta 1a) was approved for R-R MS.
- In 1996, Copaxone[®] (glatiramer acetate) was approved for R-R MS.
- In 1986, the Consortium of Multiple Sclerosis Centers (CMSC) was founded. The CMSC is the largest organization of MS health professionals in the world. It holds annual and regional meetings, consensus conferences, and training programs for MS professionals. It has a journal (*International Journal of MS Care*) and a newsletter (*The MS Exchange*). The CMSC Foundation funds scholarships and fellowships in MS training; the CMSC NARCOMS project has a large patient database to increase understanding of MS and its ramifications. Many studies have used the database.
- In 1991 Rehabilitation in Multiple Sclerosis (RIMS), a European network, was founded. The European Committee on Treatment and Research in MS (ECTRIMS) was founded shortly thereafter. ACTRIMS, the North American counterpart, was established followed by LACTRIMS, a Latin American organization representing Central and South America.
- In 1997, the International Organization of MS Nurses (IOMSN) was founded. The Goals and Strategies of the IOMSN are to:
 - A. Facilitate the development of a specialized branch of nursing in MS:
 - 1. Develop and maintain a mechanism by which members can share information on practice positions and resources
 - 2. Establish the IOMSN as a forum for discussion and collaboration on issues that concern MS nurses
 - 3. Serve as a resource for external organizations related to MS practice issues
 - 4. Promote the acknowledgment of the contribution of IOMSN as the pre-eminent organization of MS nurses
 - 5. Participate with other nursing organizations involved in MS care or related fields
 - 6. Share information on research activities among members
 - B. Establish standards of nursing care in MS:
 - 1. Develop minimal standards of nursing practice in MS
 - 2. Facilitate the development of a core curriculum for MS nursing to disseminate this information
 - 3. Identify specific domains of MS nursing and define basic roles and responsibilities in each domain

- C. Support multiple sclerosis nursing research, basic research, and clinical trials:
 - 1. Encourage research activities that contribute to the development of a sound theoretical basis for MS practice
 - 2. Recommend research topics for educational sessions at IOMSN meetings for dissemination of evidence-based information
 - 3. Develop and implement nursing research
 - 4. Disseminate MS nursing research findings through publications and educational activities
- D. Educate the healthcare community about MS:
 - 1. Promote communication among the IOMSN membership via the newsletter, web site, and other venues
 - 2. Facilitate internal and external communication about MS care and research
- Multiple Sclerosis International Credentialing Board (MSNICB) was founded in 2001
 - A. The MSNICB is responsible for the development and administration of the Certification examination in MS nursing.
 - B. The International Organization of Multiple Sclerosis Nurses (IOMSN) endorses the concept of voluntary certification by examination for all nursing professionals providing care in MS. Those who work or have worked in this specialty and meet eligibility requirements may be candidates to take this examination. Certification focuses specifically on the individual and is an indication of knowledge and skills and MS practice. MS nursing certification provides formal recognition of a level of knowledge in the field and promotes the delivery of safe and effective practice in the domains of Clinical Practice (disease course and classifications, epidemiology and distribution); Advocacy (ethical practice, negotiating the healthcare system, empowerment, knowledge of community resources, patient rights, consultation expertise); Education (principles of teaching/learning, health promotion and change theory, special populations, professional development); and Research (evidence-based practice, protection of human subjects, research terminology and process).

- C. All candidates must be licensed nursing professionals with at least two years' experience in MS. Candidates must also agree to adhere to the IOMSN Code of Ethics.
- D. The basic content of the examination covers:
 - 1. Basic concepts of MS (disease course classification, pathophysiology of MS, diagnostic process)
 - 2. Pharmacologic and nonpharmacologic treatment
 - 3. Symptom management
 - 4. Psychosocial intervention
 - 5. Research and education initiatives
 - 6. Patient advocacy

Chapter 3

Change Theory and Its Application in MS Nursing

Objectives:

Upon completion of this chapter, the learner will:

- Discuss the conceptual framework of change theory
- ◆ Describe its application in MS nursing
- Systems theory is useful as a framework for viewing change since it provides a scheme for organizing information.
- A systems theory model emphasizes unity and holism and seeks to avoid fragmented approaches.
- The goal of a systems model is to provide a framework in which parts are connected and integrated.
- Open systems freely exchange information and energy as they attempt to maintain a balanced state.
- During change, the person of the change agent's system interacts with the patient's system to influence change and adaptation.
- A change agent must be especially sensitive to feedback in order to determine how activities, ideas, and new programs are being accepted.
- Change must be planned with respect for environmental systems and resources.
- The change agent must be astute to recognize biased or erroneous sources of information so that undue system disruption does not take place.
- One must consider the unique and highly personal values of each individual in order to initiate change.
- Resistance can be minimized if the change agent keeps the systems open and dynamic.

- The role of change agent is a challenging opportunity. Power is derived either from relationships or expertise or both. When the change agent advocates an innovation that is not satisfactory to the system, resistance can come into play.
- These principles can be applied to patient and family education in terms of:
 - A. Adapting to new lifestyles related to MS
 - B. Changing roles and responsibilities
 - C. Learning and adopting complex protocols to manage MS
 - D. Adjusting to the dynamic nature of the disease

Multiple Sclerosis Nurses' Code of Ethics

A multiple sclerosis (MS) nurse has a professional moral obligation. The purpose of this obligation is to guide the MS nurse in the practice of multiple sclerosis nursing. This moral obligation is defined as performance of a morally good act, or rather, what ought to be done or should be done. The multiple sclerosis nurse provides care to promote the health and well-being of MS patients and families.

Ethical principles that guide the MS nurse are: beneficence, nonmaleficence, stewardship, autonomy, and justice.

Beneficence: Moral requirement to promote good
Nonmaleficence: Do no harm
Autonomy: Respect for self-determination
Stewardship: Preserve your own being
Justice: Fair and equitable determination distribution of resources and fair treatment for individuals and society

ANA Code of Ethics for Nurses

- 1. The nurse, in all professional relationships, practices with compassion and respect for the inherent dignity, worth, and uniqueness of every patient, unrestricted by considerations of social or economic status, personal attributes or the nature of the health problem.
- **2.** The nurse's primary commitment is to the patient, whether an individual, family, group or community.
- **3.** The nurse promotes, advocates for, and strives to protect the health, safety, and rights of the patient.

- **4.** The nurse is responsible for and accountable for individual nursing practice and determines the appropriate delegation of tasks consistent with the nurse's obligation to provide optimum patient care.
- **5.** The nurse owes the same duties to self as to others, including the responsibility to preserve integrity and safety, to maintain competence, and to continue personal and professional growth.
- **6.** The nurse participates in establishing, maintaining, and improving healthcare environments and conditions of employment conducive to the provision of quality healthcare and consistent with the values of the profession through individual and collective action.
- **7.** The nurse participates in the advancement of the profession through contributions to practice, education, administration, and knowledge development.
- **8.** The nurse collaborates with other health professionals and the public in promoting community, national, and international efforts to meet health needs.
- **9.** The profession of nursing, as represented by associations and their members, is responsible for articulating nursing values, for maintaining the integrity of the profession and its practices, and for shaping social policy.

(June 30, 2001 American Nurses Association)

• Guiding principles of the MS nurse:

- A. Seeks what is good for patients and families.
- B. Recognizes that quality of life is defined by the person with MS.
- C. Recognizes and respects the patient's right to care regardless of age, race, gender, ethnicity, religion, lifestyle, sexual orientation, economic status, or level of disability.
- D. Recognizes the patient's right to MS specialist care.
- E. Promotes impartial treatment.
- F. Recognizes the patient's right to treatment and therapies, including experimental treatments.
- G. Recognizes the patient's right to access to MS drugs.
- H. Knows that patients have the right to be informed and understand advanced healthcare directives (living wills and durable

powers of attorney), concerning the right to receive resuscitation, refuse appropriate treatment, request do-not-resuscitate orders, or request the discontinuation of life support measures.

- I. Is responsible for providing information to the MS patient and family in order to facilitate informed consent for all treatments and procedures.
- J. Participates in research and is aware of the principles of informed consent, criteria for inclusion and exclusion in research protocols, and the right of the individual to withdraw from a protocol at any time.
- K. Recognizes and maintains the patient's privacy, assuring confidentiality, except when there is a clear, serious, and immediate danger to the patient or others.
- L. Has a moral obligation to offer access to care, cost containment, and quality care.
- M.Affirms that MS patients have a right to be informed, without bias, coercion, or deception, about treatment options, potential effect, and adverse effects of treatments.
- N. Supports the fact that MS patients have a right to refuse treatment, continuing to receive alternative care.
- O.Recognizes that the MS patient has a right to review his medical record and the right to have information explained.
- P. Requires participation of the MS patient in an ongoing partnership to develop an effective plan of care. This process considers diversity, individual autonomy, and responsibility.
- Q. Practices competently, consulting and referring when indicated by professional judgment.
- R. Takes appropriate action to protect patients from harm when endangered by incompetent or unethical clinical practice.
- S. Promotes and supports improved practice through professionalism, education, certification, and nursing research.
- T. Promotes local and national efforts to improve public education, legislation to ensure access to quality care, and long-term care initiatives that meet the health needs of MS patients and families.

- The *incidence* or *attack rate* is defined as the number of new cases of the disease beginning in a unit of time within a specified population. This is usually given as an annual incidence rate in cases per 100,000 per year. The date of onset of clinical symptoms decides the time of accession although, occasionally, the date of first diagnosis is used.
- Prevalence is easier to calculate than incidence because all cases are included regardless of disease duration. Nevertheless, accurate assessment of prevalence is still difficult because of the difficulty of full disease ascertainment.
- The *point prevalence rate* is more properly called a *ratio* and refers to the number of diagnoses within the community.
- The major clinical criteria in current use for MS are those by the Poser committee and a recent set of criteria that includes cases with monosymptomatic onset proposed by McDonald that strongly emphasizes MRI findings.
- Kurtzke classified MS prevalence rates into high, medium, and low risk groups. High-risk areas such as northern and central Europe,

Italy, the northern United States, Canada, southeastern Australia, New Zealand, and parts of the former Soviet Union are considered high risk, with rates greater than 30 per 100,000 populations.

- Medium-risk areas (prevalence between 5 and 29 per 100,000) include southern Europe, the southern United States, northern Australia, northernmost Scandinavia, much of the north Mediterranean basin, parts of the former Soviet Union, white South Africa, and possibly central South America. Low-risk areas (less than 5 per 100,000) include other areas of Africa and Asia, the Caribbean, Mexico, and possibly northern South America.
- As early as the 1920s it was recognized that the distribution of MS was not uniform. In general, people who reside in temperate climates in economically developed occidental countries tend to have a higher rate of MS.
- In the Northern Hemisphere, a diminishing north-south gradient has been well described.
- In the Southern Hemisphere, the reverse has been reported.
- There have been numerous reports of "clusters" in which several cases of MS have occurred at a similar point.
- Multiple sclerosis susceptibility has long been known to vary according to sex. Females are more susceptible than males in a ratio greater than 2:1.
- A review of the literature found that relatives (siblings, firstdegree cousins, second-degree cousins) have an increased risk of MS susceptibility.
- Recent studies found a strong correlation for MS susceptibility in monozygotic twin pairs when compared with non-twin MS sibling pairs.
- The average age of onset is 10 to 59 years with the highest incidence between 20 and 40 years.
- The role of infectious agents as triggering factors has been proposed but there is no evidence to support this.
- Pregnant women have been followed through their pregnancies and to six months after delivery. There is a seven-fold decrease in exacerbations during pregnancy and a seven-fold increased risk during the six months after delivery.
- Several autoimmune diseases have been associated with multiple sclerosis. No data strongly link associations but anecdotal reports

exist of relationships to diabetes mellitus, rheumatoid arthritis, myasthenia gravis, and bipolar illness.

- Data are influenced by temporal differences as well as by differences in healthcare systems, neurologic expertise, and even by cultural practices.
- Measures of disease frequency involve a numerator (cases), and a denominator (population at risk). Incidence and death rates refer to new cases and to deaths per unit time and population.
- Prevalence rates refer to cases present at one time per unit populations.
- Incidence and prevalence rates are derived from surveys of the disease within certain population; death rates come from published governmental sources.
- There is a clear predilection for whites, but other racial groups share the geographic distributions of the whites although at lower levels.
- Prevalence studies for migrants from high-risk to low-risk areas indicate the age of adolescence to be critical for risk retention, since those older than 15 years who migrate retain the MS risk of their birthplace. Those migrating before the age of 15 acquire the lower risk of their new residence.
- Migration data support the idea that MS is ordinarily acquired in early adolescence with a lengthy "incubation" or latent period between disease onset and symptom onset. Susceptibility appears to extend to approximately age 45.

Chapter 6

The Complete Neurologic Examination

Objectives:

Upon completion of this chapter, the learner will:

- ◆ Describe key components of a neurologic examination
- ◆ Discuss clinical implications of positive findings
- Cite the importance of patient and family education to explain the neuropathology of disease

Taking the history:

- A. The first and most important step in a focused assessment is gathering a detailed and accurate history in chronologic order.
- B. Family members or significant others may help contribute information.
- C. While taking the history, appraise the patient's conversational style. Is it coherent? Is the language fluent? Is the language appropriate for the level of education?
- D. Assess level of consciousness, orientation memory, intellectual status, and speech.

Mental status:

- A. The mental status assesses the following:
 - 1. Orientation to time: "What is the date today?"
 - 2. Registration: "Listen carefully. I am going to say three words and you repeat them to me after I stop."
 - 3. Naming: "What is this?" (Point to a pencil or pen.)
 - 4. Reading: "Please read this and do what it says." (Show the words on the stimulus form "Close your eyes.")
 - 5. The total score is a sum of each of the 11 evaluations. Each evaluation is scored with regard to the number of tasks per-

formed correctly. For example, if a patient is able to correctly recall only two of the three objects, a score of 2 is given. A mental status score of less than 20 points out of a maximum of 30 indicates a cognitive deficit.

Cranial nerves:

- A. CNI—Olfactory nerve involves assessment of the sense of smell.
- B. CNII—Optic nerve involves assessment of visual acuity and gross visual fields as well as an ophthalmosopic examination.
- C. CNIII, IV, and VI are responsible for pupillary constriction elicited by shining a light into each eye. Each pupil should constrict directly and consensually (constriction of the opposite pupil). A pupillary difference (aniscoria) up to 20% may be pre-existing and normal. This nerve also innervates the extraocular muscles that affect lateral and vertical gaze and is tested with CN IV, which innervates the superior oblique muscle and aids in depression of the eye and looking downward, and CNVI, which innervates the lateral rectus muscle of the eye (abduction). Testing these three nerves involves testing the extraocular eye movements (nystagmus and isolated paralysis).
- D. CNV, the trigeminal nerve, has both sensory and motor functions. Trigeminal neuralgia is a common problem in MS, and occurs when this nerve is affected.
- E. CNVII has motor and sensory components. The motor portion innervates the muscles of the face and scalp; the sensory portion supplies the sense of taste on the anterior 2/3 of the tongue and sensation to the ear canal and behind the ear.
- F. CNVIII is the acoustic nerve, which involves hearing and influences equilibrium.
- G. CNIX supplies sensory sensation to the pharynx, tonsils, and posterior 2/3 of the tongue.
- H. CNX is the vagus nerve; it is involved in the gag reflex and is tested with CNIX.
- I. CNXI controls the movement of the sternocleidomastoid and trapezius muscles of the neck and shoulders.
- J. CNXII is the motor nerve of the tongue.

I—Olfactory	Smell
II—Optic	Vision
III—Oculomotor	Eye movement, pupil contraction, accommodation, eyelid movement
IV—Trochlear	Up and out movement of eye
V—Trigeminal	Facial sensation, chewing

Motor assessment:

- A. Motor assessment techniques test muscle innervation by spinal nerves.
- B. Biceps involve elbow flexion and originate at C5 and C6.
- C. Triceps involve elbow extension and originate at C7, T1.
- D. Rectus abdominus involve trunk flexion and originate at T6-L1.
- E. Iliopsoas involve hip flexion and originate at L2 and L3.
- F. Quadriceps involve knee extension and originate at L2, L4.
- G. Biceps femoris involve knee flexion and originate at L5 and S2.
- H. Evaluation of arm drift is a sensitive test for weakness in the upper extremities.
- I. Other sensitive tests for extremity weakness include hand grasp, plantar flexion of the foot, and dorsiflexion of the foot.
- J. *Atrophy*—observe large muscle groups for symmetry and determine if their size is appropriate for the person's age.
- K. *Tone*—observe and test muscles for flaccidity, spasticity, or rigidity. Rigidity presents as stiffness regardless of the rate of passive movement. When an extremity is rigid, it "catches" during passive movement.
- L. Spasticity is dependent on the rate of movement. When the spastic extremity is moved slowly, the tone appears normal.

If the extremity is moved quickly, it "catches" and loses all resistance.

0/5	No contraction
1/5	Visible/palpable muscle contraction but no movement
2/5	Movement with gravity eliminated
3/5	Movement against gravity only
4/5	Movement against gravity with some resistance
5/5	Movement against gravity with full resistance

Sensory examination:

- A. Basic sensory examination consists of pain, light touch, proprioception, stereognosis, and vibration:
 - 1. *Proprioception* measures posterior column defects (position of toe—up or down, etc.)
 - 2. *Stereognosis* is dependent on touch and position sense (identification of a familiar object in one's hand).
 - 3. *Vibration sense* is tested by placing a vibrating tuning fork over the distal interphalangeal joint of a finger and the great toe.

Cerebellum and gait:

 A. The cerebellum organizes and coordinates movements but does not control individual muscles. Smooth, coordinated movements depend on the normal functioning of the cerebellum. *Ataxia* describes disorganized, unsteady, or inaccurate movements. Tests include finger to nose, heel-knee-shin, the Romberg test, and gait assessment.

Reflexes:

- A. The major deep tendon reflexes are:
 - 1. Achilles (S1, S2)
 - 2. Patellar (L3, L4)
 - 3. Biceps (C5, C6)
 - 4. Triceps reflexes (C7, C8)
 - Grading is on a scale from 0–4+. Zero reflects no contraction (absent reflex), 1+ is diminished but present, 2+ is normal, 3+ is increased, 4+ is hyperactive with clonus.

- 6. Assymetric reflexes indicate neurologic (or muscular) dysfunction.
- Cerebellar disorders:
 - A. *Ataxia*—awkwardness of posture and gait; tendency to fall to the same side as the cerebellar lesion; poor coordination of movement; overshooting the goal in reaching an object (*dysmetria*); inability to perform rapid alternating movements (*dysdiadochokinesia*), such as finger tapping; scanning speech due to awkward use of speech muscles, resulting in irregularly spaced sounds.
 - B. Decreased tendon reflexes on the affected side.
 - C. Asthenia—muscles tire more easily than normal.
 - D. *Tremor*—usually an intention tremor (evident during purposeful movements).
 - E. Nystagmus.
- Miscellaneous notes:
 - A. The *left visual field* falls on the right half of each retina; the *superior visual field* falls on the inferior retina. The left visual field projects to the right side of the brain, and vice versa.
 - B. The superior visual field projects below the calcarine fissure in the occipital lobe.
 - C. Nystagmus is a repetitive, tremorlike oscillating movement of the eyes. The most common form is *horizontal jerk nystagmus*, in which the eyes repetitively move slowly toward one side and then quickly back. Vertical nystagmus is always abnormal, signifying a disorder in brainstem function.
 - D. *Pendular nystagmus*, in which one eye moves at equal speeds in both directions, commonly is congenital.
 - E. *Doll's Eye Phenomenon* occurs when the head is turned suddenly to one side. Normally, there is a tendency for the eyes to lag behind. This reflex is believed to be brainstem mediated, and any asymmetry or lack of response is believed to reflect significant brainstem dysfunction.

Magnetic Resonance Imaging

Objectives:

Upon completion of this chapter, the learner will:

- ◆ Describe the role of MRI in the diagnosis and treatment of MS
- ◆ Discuss MRI in relation to disease modifying therapies
- ◆ Cite the use of MRI in MS research

Basic overview of MRI:

- A. Magnetic resonance imaging is commonly referred to as MRI.
- B. Unlike CAT (computed axial tomography) scans, MRI does not use X-rays to create pictures of the body.
- C. The technology uses a complicated array of physics, mathematics, and high-performance computing techniques.
- D. An MRI scanner consists of a very large and very strong, but harmless, magnet; the patient lies within the magnet's field.
- E. The scanner generates pictures by analyzing how water molecules react to electrical impulses in this strong magnetic environment.
- F. This involves radio frequency waves.
- MRI principles:
 - A. When a person lies in the magnetic field on an MR unit, protons align with the axis of the magnet.
 - B. A radiofrequency pulse is transmitted, rotating the protons.
 - C. When the pulse is turned off, the protons return to their previous states. Measurement of this activity is called T1 and T2.
 - D. MS lesions have T1 and T2 relaxation properties because of free water associated with edema and inflammation and because of tissue destruction.

- E. Pulse sequences used for MRI are known as spin-echo.
- F. *Gadopentetate* (gadolinium) is a contrast agent to identify active MS lesions.
- G. MS scans should include the entire brain, although MS lesions are most frequent in the periventricular region.
- H.T1W or T1 *black holes* are subsets of chronic T2 lesions that appear hypointense on T1W images and have extensive tissue destruction.
- It is likely that hypointense lesions on T1-weighted images represent the more disabling lesions and that these lesions correlate with persistent neurologic deficit in people with MS.

- Uses of MRI in MS:
 - A. The primary use of MRI in MS is to confirm the diagnosis and rule out other possible conditions.
 - B. MRI may also be able to predict the course of MS since research has shown that people who have MRI activity repre-
senting new MS lesions will continue to have MRI activity over subsequent months and years.

- C. MRI may also be used to monitor the effectiveness of drugs in clinical trials.
- D. MRI lesions may precede overt symptoms as seen in studies of the natural history of MS.
- E. MRI has provided valuable insights into the course of the illness and has helped to identify new therapies that have at least a partial effect on disease activity.
- F. Under the new diagnostic criteria proposed by McDonald, et al., T2 weighted lesions in the periventricular white matter, brain stem, and spinal cord, and Gd-enhancement on T1 imaging, along with hypointensities (black holes) on T1 images, support the diagnosis of MS.
- The evolution of the MS lesion:
 - A. Disruption of the blood-brain barrier with inflammation.
 - B. Gadolinium enhancement occurs at active sites.
 - C. This enhancement usually subsides in 3 to 6 weeks, leaving a "white spot" on the MRI image.
 - D. Sometimes these areas become larger and reinflamed with new disease activity, then once again subside.
 - E. Over time, repeated inflammation may cause extensive damage within the lesion, leaving what are known as black holes.
 - F. New MRI lesions can be "clinically silent." Several factors influence whether a lesion visible on MRI correlates with an overt clinical sign or symptom. These are:
 - 1. Location of the lesion
 - 2. Number of lesions
 - 3. Severity of the damage
 - G. In the relapsing-remitting phase, a great deal of MRI activity occurs.
 - H. In the secondary-progressive phase, there are more symptoms and less MRI activity occurs; there are fewer acute inflamed lesions and more chronic, older lesions that reflect irreversible axonal damage and atrophy. MRI activity may fall off because there is less inflammatory activity.
 - I. The use of MRI in the diagnosis of MS and as a surrogate outcome measure has emerged as very important in diagnosing,

treating, and studying multiple sclerosis. It is likely that this technology will play a larger role in the long-term management of MS. Other technology, magnetization transfer MRI (MT) and magnetic resonance spectroscopy (MRS) have been applied to the evaluation of MS patients. MT changes may reflect changes in myelin although edema may also contribute to changes. MRS can detect changes in metabolites.

Chapter 8

Determining the Diagnosis and Prognosis of Multiple Sclerosis

Objectives:

Upon completion of this chapter, the learner will:

- ◆ Describe the pathophysiology of MS
- ◆ Describe common symptoms of MS
- ◆ Discuss the diagnostic process in MS
- ◆ Cite the common disease courses seen in MS
- Identify common laboratory tests used in the diagnostic process

Multiple sclerosis is a clinical diagnosis because there is no definitive laboratory test. It is common practice to perform a battery of pertinent investigations to exclude other conditions and to provide objective evidence that MS is the correct diagnosis. This also enables the neurologist to create a prognostic profile to guide therapeutic choices.

- Pathophysiology of MS:
 - A. The etiology of MS is not known.
 - B. The most widely believed hypothesis is that it is a virusinduced autoimmune disease.
 - C. A great deal of effort has gone into attempts to understand the immunology of MS using the animal model, experimental autoimmune encephalomyelitis (EAE).
 - D. For normal nerve fibers, the myelin sheath has a uniform thickness and myelin segments between nodes of Ranvier (internodal segments) are of uniform length except near the end of each fiber, where internodes become progressively shorter.

- E. The pathology of MS consists of lesions disseminated in location and of varying age. Lesions are present in both white and gray matter, but the gray matter lesions are less evident on casual inspection. Oligodendrocytes are damaged in this process.
- F. Lesions range from acute plaques with active inflammatory infiltrates and macrophages loaded with lipid and myelin degeneration products to chronic, inactive, demyelinated scars.
- G. Slowed conduction and conduction failure occurs in demyelinated fibers. Conduction failure is due to fiber fatigue or to an increase in body temperature or both.
- H. Ongoing inflammation, demyelination, and scarring ultimately result in irreversible axonal damage and loss.
- I. Acute MS lesions are characterized by T lympohocytes, plasma cells, macrophages, and bare, demyelinated, or transected axons.
- J. Brain atrophy in MS is widely recognized and represents a negative pathologic change. It may develop as an early measure of disease progression, and its slowing may be used as a measure of therapy efficacy in long-term management.
- Demographics of MS:
 - A. Most patients are young women whose presenting symptoms are episodic neurologic problems that spontaneously improve.
 - B. The less common presentation is an older man or woman who has gradual development of neurologic deficits. Most often this takes the form of a progressive myelopathy.
 - C. 70 to 75% of patients with MS are female.
 - D. The only exception to this is in primary progressive MS, in which there is an equal ratio.
 - E. Most MS patients are Caucasian.
 - F. MS is rare among Africans, Asians, and Native Americans.
 - G. African Americans have levels of MS consistent with the mixing of the gene pool.
 - H. Asians are more likely to have spinal cord-optic nerve disease. This type of MS has an older age onset, fewer brain lesions on MRI, and more enhancing lesions in the spinal cord.
 - I. The average age of onset is 28 to 30 years.
 - J. Fewer than 1% have an onset before age 10; before age 16 1.2 to 6%.

- Prognostic factors in MS:
 - A. Positive predictors in MS include:
 - 1. Younger age at onset
 - 2. Female sex
 - 3. Normal MRI at presentation
 - 4. Complete recovery from first relapse
 - 5. Low relapse rate
 - 6. Long interval to second relapse
 - 7. Low disability at 2 and 4 years
 - B. Unfavorable predictors in MS include:
 - 1. Older age at onset
 - 2. Male sex
 - 3. High lesion load on MRI at presentation
 - 4. Lack of recovery from first relapse
 - 5. High relapse rate
 - 6. Early cerebellar involvement
 - 7. Short interval to second relapse
 - 8. Early development of mild disability
 - 9. Insidious motor onset
- Clinical profile of MS:
 - A. Requires symptomatic disease over time, confirmed by objective evidence on neurologic examination. Symptomatic disease means neurologic worsening in the form of episodic attacks or slow progression.
 - B. The most common presentations are:
 - 1. Sensory disturbance such as numbness, paresthesias, pain, or Lhermitte's sign (21–55% of patients):
 - often begins in the limbs and migrates proximally, in
 tingling
 - ♦ Lhermitte's
 - ✦ neuritic pain
 - ✦ diminished vibratory sensation
 - ✦ impaired position sense
 - "useless hand syndrome"
 - 2. Motor abnormalities:
 - ♦ corticospinal (32–41%)
 - ♦ heaviness, weakness, abnormal DTRs
 - \diamond positive Babinski response

- ♦ spastic limb weakness
- 3. Visual problems:
 - ♦ brainstem
 - ◆ eye movement abnormalities (diplopia nystagmus, INO)
 - ♦ optic neuritis (in up to 25% of patients)
- 4. Cerebellar gait ataxia limb ataxia tremor
- C. Laboratory testing is used to help document that there are no alternative disorders to explain the neurologic picture and that there is a pattern of CNS lesion involvement consistent with MS, with no white matter involvement.
 - 1. Previous diagnostic criteria (Schumacher and Poser) have been supplemented by new criteria for a clinical isolated attack (CIS) to allow for an MRI supported diagnosis.
 - 2. The newer McDonald criteria, proposed in 2001:
 - Developed by a large international committee funded by NMSS and MSIF to revise criteria to include new technology
 - Preserves traditional diagnostic criteria of two attacks of disease separated in space and time
 - ✦ Must be no better explanation
 - ◆ Adds MRI, CSF, and EP criteria
 - ✦ Three possible outcomes after work-up:
 - ♦ Multiple Sclerosis
 - ✤ Possible MS
 - ♦ Not MS
 - ✤ Monosymptomatic presentation:
 - ♦ One attack
 - ♦ One objective clinical lesion
 - ♦ MRI evidence
 - ✦ Primary progressive MS:
 - \diamondsuit Positive CSF and dissemination in space
 - \diamondsuit MRI evidence along with evoked potentials and CSF
 - ✤ Continued progression over one year
 - ✦ Although MRI is recognized as an invaluable tool, it is not appropriate to use it in isolation. Diagnosis should always be made in the clinical context.
 - Paraclinical evidence along with MRI includes cerebrospinal fluid with IgG oligoclonal bands or intrathecal IgG production.

- Evoked potential tests are used to document lesions disseminated in space to provide objective evidence to document subjective complaints or to confirm a pattern of CNS involvement consistent with MS. Nerve conduction is studied in the visual tracts, in the brainstem, and through the spinal cord (VEP, BAEP, and SEP).
- Immunology of MS:
 - A. The evidence for immune system involvement in MS is fairly clear while evidence that it is an autoimmune disease is more indirect.
 - B. People with MS seem to have clear-cut abnormalities in immune function.
 - 1. Unusually high reactivity of immune system T-cells to proteins of myelin in the CNS (termed antigens since they can trigger immune responses)
 - 2. An over-representation of cells that enhance immune responses (T-helper cells).
 - 3. A relative under-representation of cells that suppress immune responses (suppressor T-cells)
 - 4. The presence of immune system cells in MS lesions in the brain, spinal cord, and optic nerves.
 - 5. Recently, the role of B-lymphocytes that are responsible for producing antibodies has been emphasized.
 - 6. "Direct" evidence that MS is an autoimmune disease is difficult to obtain in humans, but in the animal model (EAE), it is clear.
 - 7. Many studies during the latter part of the twentieth century increased our understanding of the immune system's reactivity to myelin in MS, including specificity immune responses to myelin antigens.

Etiology of MS:

- A. The genetic link in MS is borne out by the fact that:
 - 1. There is an increased susceptibility in certain families in which MS already occurs
 - 2. Some genetically isolated ethnic groups never develop MS (Hutterites in Canada; East European gypsies).
 - 3. The racial differences in MS prevalence are likely to be genetically based.

- 4. While genetics play a role in MS susceptibility, the nature of the link is both complex and largely unknown.
- 5. There is great interest in environmental triggering factors. Over the decades, there have been studies of retroviral (HTLV-1, HHV6, and canine distemper), and bacterial (chlamydia pneumoniae, et al.) triggers.
- 6. Evidence is anecdotal at this point, with no substantiation in research.
- Clinical subtypes of MS (disease courses):
 - A. Primary progressive MS involves slow worsening from onset and is considered as a single attack. These patients may have to be observed over time; 15% of people with MS show this pattern.
 - B. Relapsing-remitting MS patients experience neurologic attacks with variable recovery but are clinically stable between attacks. Among this group are a minority of patients who will have minimal disease activity and little or no disability 25 years into their disease. These patients have benign or mild MS and may comprise 10 to 20% of those with MS.
 - C. Secondary progressive MS is the major progressive form of the disease and accounts for approximately 30% of all MS patients. These patients start with relapsing-remitting disease then slow-ly begin to worsen.
 - D. By 10 years, 50%, and by 20–15 years at least 80%, of untreated relapsing patients will become secondary progressive.
 - E. An additional term in the literature, *transitional MS*, refers to those patients who are evolving into the secondary progressive stage.
 - F. Some patients begin with no attacks and a progressive course, and later in their disease begin having exacerbations (progressive-relapsing).
 - G. Clinically isolated syndromes (CISs) are monoregional acute monophasic syndromes that encompass optic neuritis, transverse myelitis, isolated brainstem, or cerebellar syndromes. These patients have a high risk of MS, as confirmed by recent studies. MRI scans with T2 lesions predict a greater than 80% conversion to MS by 10 years.
- Red flags in the diagnosis of MS:
 - A. One should be concerned about patients who:
 - 1. Have not had any laboratory tests

- 2. Have normal neurologic examinations and normal laboratory studies
- 3. Have only peripheral nerve involvement
- 4. Have disease onset at a very early or very late age

• The immune system protects people from pathogens such as:

- A. Bacteria
- B. Viruses

 - 1. Innate immunity
 - 2. Adaptive immunity
- The immune system comprises:
 - A. Innate immunity:
 - 1. Immunity to certain pathogens; this is common to all healthy individuals
 - 2. Does not require prior exposure to the pathogen
 - 3. Immediate destruction of some pathogens by phagocytic cells such as macrophage and neutrophils
 - B. Adaptive immunity:
 - 1. Requires exposure to pathogen to stimulate immune system response
 - 2. Cellular immunity
 - ✦ Cytotoxic T-cells (CD 8)
 - \bullet T_H1 cells (CD 4)

- 3. B lymphocytes
- 4. Antibodies
- 5. Activation of complement
- C. Cells of the immune system begin life in the bone marrow as stem cells
- D. T-cells are differentiated in the thymus
- E. B-cells are differentiated in the bone marrow
- F. These cells are activated in the lymphoid tissues where they are presented with antigen
- G. B-cells recognize an antigen that is present outside of cells
- H. T-cells detect antigens generated inside host cells
- I. Both B-cells and T-cells must receive an additional signal in order to be activated
- Humoral immunity is produced by:
 - A. Antibodies produced by B-cells
 - B. Antibodies work by
 - 1. *Neutralization*—binding to pathogens and blocking the path to body cells
 - 2. *Opsonization*—enabling phagocytic cells to recognize pathogens by coating the pathogen

- Cellular immunity is produced by:

- 5. These cells display antigen protein particles on specialized cell surface molecules known as MHC.
- 6. Two classes of MHC molecules exist:

- ♦ MHC I
- ♦ MHC II
- 7. MHC I are recognized by cytotoxic T-cells (CD8).
- MHC II are expressed on the surface of macrophages or B-cells and are recognized by T_H1 or T_H2 cells (CD4).
- 9. CD 4 Cell cytokine production:
 - \bullet T_H1 cells activate macrophages and produce:
 - ♦ interferon gamma
 - ♦ TNF alpha
 - ♦ TNF-beta
 - ♦ IL-2
 - $T_{\rm H}^2$ cells activate B-cells and produce:
 - � IL-4
 - � IL-5
 - � IL-10
 - ♦ TGF-beta
- Inappropriate immune response includes:
 - A. Allergy
 - B. Autoimmune disease
- Allergy is the result of a specific IgE antibody to an innocuous antigen.
- In autoimmune illness:
 - A. T-cells that recognize self-antigen are normally deleted.
 - B. The regulatory mechanisms that keep these cells in check are not working properly.
 - C. Without regulation, autoreactive T-cells can proliferate.
 - D. Molecular mimicry occurs:
 - 1. Self-protein is structurally similar to non-self-antigen.
 - 2. T-cells can recognize self-antigens if they are sufficiently similar to the non–self-antigen.
- In multiple sclerosis:
 - A. T_H1 cells are stimulated in the periphery by presentation with antigen (i.e., a virus particle).

- D. They then become reactivated, releasing the damaging cytokines interferon gamma, TNF-alpha, TNF-beta, and IL-2.
- Disease modifying treatments include:
 - A. Immunomodulating and immunosuppressive agents that have an effect on some aspect of the immune response.
 - B. With some agents, the effect is general, with others more specific.
 - C. Interferon beta:
 - 1. Inhibits T-cell proliferation
 - 2. Inhibits synthesis of inflammatory cytokines (IFN-gamma, TNF-alpha)
 - 3. Downregulates expression of MHC class II molecules induced by IFN-gamma
 - 4. Reduces antigen presentation to T-cells
 - 5. Downregulates adhesion molecules and promotes BBB integrity
 - D. Glatiramer acetate:
 - 1. Induces suppressor T-cells
 - 2. Is structurally similar to myelin basic protein. When GA-induced T-cells are presented to MBP in the CNS, they are stimulated to proliferate and release cytokines (TGF-beta, IL-4, IL-10)
 - E. Immunosuppressants:
 - 1. Cyclophosphamide is a broad-spectrum immunosuppressant
 - 2. *Mitoxantrone* has a broad spectrum of immunosuppression with some B-cell suppression
 - 3. *Imuran* is a broad-spectrum immunosuppressant with milder effect and some B-cell suppression
 - 4. Methotrexate has little immunosuppression

Disease Altering Therapies

Objectives:

Upon completion of this chapter, the learner will:

- ◆ Discuss relapse management in multiple sclerosis
- ◆ Describe immunomodulation in relapsing forms of MS
- ◆ Cite management of worsening disease
- ◆ Describe strategies to promote adherence to complex protocols

Relapse management:

- A. A relapse is the appearance of a new symptom or the reappearance of a previous symptom of MS after the initial attack. A relapse cannot be related to an intercurrent infection or any other environmental factor and must last more than 24 hours.
- B. High-dose intravenous (or oral, depending on patient's place of residence) corticosteroids:
 - 1. Methylprednisolone
 - 2. Prednisone
 - 3. Dexamethasone
 - 4. ACTH (rarely used)
- C. No proof of benefit on relapse rates and progression
- D. Minimal evidence on optimal dose or regimen
- E. Protocols vary from country to country
- Immunoregulators:
 - A. Azathioprine (oral)
 - 1. No good double-blind, placebo-controlled studies but evidence suggests slight effect on disease activity
 - B. Cyclophosphamide (IV or oral)
 - 1. Conflicting studies

- 2. High adverse effect profile
- 3. Many varying protocols
- 4. May be used for "rescue therapy"
- C. Cyclosporine (IV)
 - 1. Has been shown to have modest effect
 - 2. High adverse effect profile
- D. Methotrexate (oral)
 - 1. Weekly low dose may help delay progression
 - 2. Research demonstrates modest effect on upper extremity function
- E. Mitoxantrone (IV)
 - 1. Studied widely in Europe
 - 2. Approved by FDA for worsening MS
 - 3. Used in aggressive, relapsing MS and in patients with inadequate response to disease modifying agents
 - 4. Has lifetime maximal dose
 - 5. Potential for cardiotoxicity
- F. Intravenous Immunoglobulin (IVIG)
 - 1. Obtained from blood of healthy human donors
 - 2. Still under investigation for use in MS with a double-blind placebo-controlled design
 - 3. Some data on improved disability but no MRI data available as yet
 - 4. Well tolerated
 - 5. Very costly
- Disease modifying therapy:
 - A. Therapies becoming available all over the world
 - B. Coverage varies greatly
 - C. In most countries, available for relapsing multiple sclerosis
 - D. Therapy initiation and ongoing adherence requires nursing services (documented in research)
 - E. Available therapies:
 - 1. Interferon beta (1-b, 1-a)
 - 2. Glatiramer acetate
 - 3. Combination therapies
 - F. Interferon beta 1-b (Betaseron® or Betaferon®)
 - 1. 8 MIU subcutaneously every other day
 - 2. Requires reconstitution

- 3. Diluent available in prefilled syringe
- 4. Autojector for injection
- 5. Benefit in relapse rates and MRI
- 6. Preliminary data on cognition and depression
- 7. In secondary progressive MS, North American study was not statistically significant; in Europe, the results were positive
- 8. Side effect profile:
 - ♦ flu-like syndrome
 - ♦ skin reactions
 - ✦ menstrual changes, abortifacient potential
 - ◆ reports of depression (refuted in 2002, Feinstein et al.)
 - ✦ neutralizing antibodies (NABs) 38%
 - ♦ leukopenia
 - ♦ elevated liver enzymes
 - ♦ thrombocytopenia
- 9. Side effect management includes patient and family education in dose titration, timing of injections, NSAIDS, site rotation, management of depression.
- G. Interferon beta 1-a (Avonex[®])
 - 1. 30 mcg (6MIU) weekly, requires reconstitution
 - 2. Slows progression measured by EDSS in relapsing MS
 - 3. Reduces relapses by 18%
 - 4. Delays onset of CDMS by one year (monosymptomatic trial-CHAMPS)
 - 5. No clear benefit in secondary progressive MS
 - 6. Benefit in brain atrophy reported
 - 7. Side-effects include:
 - ♦ flu-like syndrome
 - \blacklozenge cautious use with seizures or depression
 - ♦ abortifacient potential
 - ◆ NABs 24%
 - ✦ Elevated liver enzymes
 - 8. Side effect management includes patient and family education in dose titration, timing of injections, NSAIDS, site rotation, management of depression
- H. Interferon beta 1-a (Rebif[®])
 - 1. Two doses (22 mcg and 44 mcg) three times weekly subcutaneously

- 2. Prefilled syringes with autojector (Rebiject®)
- 3. Dose-dependent decrease in relapse and MRI disease burden
- 4. Delayed onset of clinically definite MS by 9 months (ETOMS)
- 5. Side effects include:
 - ♦ flu-like syndrome
 - ✦ site reactions and rare necrosis
 - ♦ menstrual irregularities
 - ◆ leukopenia, elevated liver enzymes, thrombocytopenia
 - ◆ NABs 23.8% low dose; 12.5% in high dose
 - Possible depression, although this was refuted in a recent study
- 6. Side effect management includes patient and family education in dose titration, timing of injections, NSAIDS, site rotation, management of depression
- I. Glatiramer acetate (Copaxone®) (combination of four amino acids
 - 1. 20 mg subcutaneously daily
 - 2. In prefilled syringe with autoinjector
 - 3. Sustained benefit in reduction of relapse rate
 - 4. Significant reduction of MRI lesion number and volume
 - 5. Being studied for primary progressive MS
 - 6. No statistical significance in oral form
 - 7. Side effects include:
 - \blacklozenge injection site reactions and pain
 - rare systemic reaction (chest pain, dyspnea, and anxiety—post-injection reaction)
 - ♦ arthralgia and nausea
- J. Common problems with disease modifying agents (DMAs):
 - 1. Spasticity
 - ✦ Commonly seen with interferon therapy
 - ✦ May occur on initiation of therapy or prior to treatment
 - Differential diagnosis between interferon-induced spasticty or spasticity associated with relapse or infection is necessary
 - ✤ Assess for other contributing factors
 - ✦ Administer anti-spasticity medications

- Consider dose adjustment of interferons until problem is managed
- 2. Laboratory abnormalities
 - ✤ No known significant abnormalities with glatiramer acetate
 - ✦ In interferon therapy, the most common abnormalities are leukopenia, neutropenia, and raised liver aminotransferase values (e.g., serum glutamic oxaloacetic [SGTOT] and serum glutamic pyruvic transaminase [SGPT])
- 3. Managing laboratory abnormalities:
 - Monitor lab values regularly following initiation of treatment
 - ✤ Inform physician of abnormal values
 - Consider dose adjustment and/or discontinuation of treatment if abnormalities persist
- K. Combination therapy
 - 1. Several studies of small sample size have shown benefit of combination therapy.
 - 2. Some of the combinations studied include Betaseron[®] and azathioprine; Betaseron[®] and Mitoxantrone[®]; Avonex[®], and Cytoxan[®]; Avonex[®] and Cytoxan[®]; Avonex[®] and azathioprine; Copaxone[®] and Betaseron[®]; Avonex[®] and Copaxone[®].
- L. Initiation of therapy
 - 1. Regardless of who makes the decision, it is imperative that the nurse educate the patient and family on:
 - ✦ all available treatments
 - ♦ efficacy and side effects
 - ♦ self-care activities
 - ✦ the importance of adherence
- M.The Psycho-Educational approach
 - 1. Requires that the patient and family become actively involved in goal setting, realistic expectations, and the process itself
- N. Patient and family education require that:
 - 1. Information is provided in a clear and concise manner.
 - 2. There is a relaxed and non-distracting learning environment.

- 3. A variety of educational tools are utilized.
- 4. Reinforcement is provided regularly.
- 5. Education should not be initiated immediately after diagnosis.
- 6. Hope can be instilled along with realistic expectations.
- 7. Patients must be motivated to learn; if they are not ready, education should be delayed.
- 8. Outcomes of education:
 - ✦ Patient should be able to:
 - \diamond describe rationale of therapy
 - ♦ correctly reconstitute and administer medication
 - ♦ manage side effects
 - ♦ identify and use resources to obtain further information
- 9. Promoting adherence:
 - ♦ establish a trusting relationship
 - ✦ consistent and clear education
 - ♦ advocate for access to treatment
 - ✦ reinforcement of the multidisciplinary team
 - ♦ ongoing patient and family contact

- Multiple sclerosis is a complex and dynamic disease.
 - A. It has a wide variety of disease patterns.

 - C. Fluctuation is based on circumstances.
 - D. Many symptoms have a cascade effect on functioning.
 - E. Careful management can improve quality of life.
 - F. Ongoing, poorly managed symptomatic problems can be devastating.
- The key to management is knowledge and skills:
 - A. Symptoms have to be recognized, understood, and discussed with the healthcare team by the patient and family.
 - B. Management should be individualized and flexible in light of the dynamic nature of MS.
- Common symptoms of multiple sclerosis:

- Less-common symptoms of multiple sclerosis:
 - A. Dysarthria, scanning speech, dysphagia
 - B. Lhermitte's sign
 - C. Neuritic pain
 - D. Vertigo/ataxia
 - E. Cognitive dysfunction
 - F. Tremor/incoordination
- Rare symptoms of multiple sclerosis:
 - A. Decreased hearing
 - B. Convulsions
 - C. Tinnitus
 - D. Mental disturbance
 - E. Paralysis
- Fatigue
 - A. May be directly due to MS
 - B. Other causes: depression, deconditioning, medications, concommitant medical conditions (thyroid dysfunction, cardiovascular disease), sleep disturbance
 - C. The most common cause of MS-related disability

- D. Can be managed with a wide variety of strategies
- E. Evaluation:
 - 1. Assess for impending exacerbation
 - 2. Screen for infection
 - 3. Question about environmental factors (heat, humidity)
 - 4. Ascertain medications, dosages, and time of dosing
 - 5. Assess sleep habits
 - 6. Question about other symptoms (pain, spasticity, bowel or bladder dysfunction)
 - 7. Assess mood
 - 8. Evaluate activity level and physical fitness
- E. Management:
 - 1. Instruct in effective energy expenditure
 - 2. Encourage the use of appropriate use of assistive devices (scooters, walkers, wheelchairs, transfer equipment)
 - 3. Encourage the use of air conditioning and other cooling techniques
 - 4. Encourage the treatment of mood disorders
 - 5. Encourage the initiation of symptom management—pain, spasticity, bowel, bladder dysfunction
 - 6. Advocate for the treatment of medical conditions causing fatigue
 - 7. Improve sleep hygiene
 - 8. Medications used to manage MS-related fatigue:
 - ✦ CNS stimulants (methylphenidate)
 - ♦ aminopyridines (currently being studied in research)
 - ♦ amantidine (SE: headache, dizziness, rash)
 - modafinil (SE: headache, tachycardia, palpitations, contraindicated in LMVP)
 - ✦ pemoline (liver cautions)
 - ♦ SSRI antidepressants
 - unique antidepressants—buprioprion (Wellbutrin[®]) (SE: seizure risk)
 - 9. Initiate appropriate conditioning programs
 - 10. Reassess patient on a regular basis
- Pain
 - A. Pain is complex; it is a sensory phenomenon
 - B. Pain inadequately defined, identified, or measured by an observer

- C. Pain is an individual, learned, social, and cultural response
- D. A common myth in MS is there "is no pain"
- E. Both acute and chronic pain can be related to MS:
 - 1. Acute pain
 - ♦ trigeminal neuralgia
 - ♦ tonic spasms
 - ✦ lightning-like extremity pain
 - ✦ painful Lhermitte's sign
 - ✤ optic neuritis and retrobulbar pain
 - 2. Chronic pain with insidious onset
 - ♦ dysesthetic extremity pain
 - ✤ bandlike pain in torso or extremities
 - ✤ back pain with radicolopathy
 - ♦ headache
- F. Trigeminal neuralgia probably arises from transmission of nerve impulses in areas of demyelination.
 - 1. Treatment consists of IV or oral steroids in the acute phase.
 - 2. In the chronic phase, anticonvulsants such as carbamazepine and gabapentin are used.
- G. Painful tonic spasms may or may not be related to spasticity. Simple flexor spasms may be related to movement or noxious stimuli. Treatment consists of antispasticity medications and anticonvulsants.
- H. Less common is the painful tetanic posturing of an arm or leg, usually on one side of the body. Treatment consists of carbamazepine, clonazepam, tizanidine, and baclofen.
- I. Lightning-like extremity pain can be treated with carbamazepine, gabapentin, and phenytoin.
- J. Lhermitte's sign responds to the above medications and also to tricyclic antidepressant medications.
- K. Headache has been reported to be causally related to demyelinating lesions. Treatment generally proceeds along the lines of headache without MS. When associated with a relapse, treatment with steroids may cause resolution of headache.
- L. Optic neuritis is due to inflammation and demyelination occurring in and around pain-sensitive meninges surrounding the optic nerve. Steroid treatment usually brings resolution of the pain.

M.Commonly used medications:

- 1. Phenytoin-best in dysesthetic pain
- 2. *Gabapentin*—useful in dysesthetic and paroxysmal pain; better SE profile than phenytoin
- 3. *Carbamazepine*—effective in pain of paroxysmal onset; e.g., trigeminal neuralgia
- 4. Clonazepam—effective in bandlike sensations
- 5. Baclofen-useful in trigeminal neuralgia
- 6. Misoprostol-contraindicated in pregnancy
- 7. Lamotrigine—limited use due to interactions and adverse events
- 8. *Tramadol*—helpful in a variety of nonrefractory pain syndromes
- 9. Tizanidine—useful adjunct in chronic pain syndrome

Spasticity

- A. 60% of people with MS have corticospinal tract involvement with some degree of spasticity
- B. Accentuation of DTR and clonus occurs, with exaggeration of flexor reflexes
- C. Spasms and stiffness are common in the quadriceps, hamstrings, and gastrocnemious muscles
- D. May be heightened during an exacerbation, with underlying infection, and with noxious stimuli
- E. Physical therapy techniques are designed to:
 - 1. Avoid secondary complications such as decubitus ulcers
 - 2. Prevent or treat contractures
 - 3. Reduce muscle hypertonia by stretching spastic muscles and by application of warm or cold packs
 - 4. Improve patient's posture
 - 5. Develop and improve useful automatic movements and thus promote maximal function
 - 6. Assist the patient to learn more coordinated movements
 - 7. Supply supportive aids such as walkers, wheelchairs, crutches, orthoses, and special shoes
- F. Screening for noxious stimuli will promote prompt treatment and reduction of spasticity.
- G. Medications for spasticity may be sedating and excessive doses may result in weakness

- 1. Baclofen
- 2. Tizanidine
- 3. Clonazepam
- 4. Diazepam
- H. Intrathecal baclofen (ITB)
 - 1. Surgically implanted pump for intrathecal baclofen delivery
 - ♦ no systemic side effects
 - ♦ expensive
 - ✦ requires surgery
 - ✦ reserved for patients in whom other interventions are unsuccessful
- Tremor, incoordination, and weakness
 - A. Most difficult problems to modify in MS
 - B. Pharmacologic regimens tend to be sedating and have limited benefit
 - C. Physical and occupational therapy may provide patient with education and assistive devices, but do not correct the underlying problem
- Dysarthria
 - A. Normal speech consists of five systems working together smoothly and rapidly:
 - 1. Respiration—using the diaphragm to fill the lungs fully
 - 2. Phonation-using the vocal cords and air flow
 - 3. Resonance-raising and lowering the soft palate
 - 4. *Articulation*—making quick, precise movements of the lips, tongue, mandible, and soft palate
 - 5. *Prosody*—combing all elements for natural flow of speech
 - B. Speech impairment has long been considered a principal symptom of MS.
 - C. Three types of dysarthria are associated with MS:
 - 1. Spastic
 - 2. Ataxic
 - 3. Mixed dysarthria
 - D. In MS, a mixed spastic-ataxic dysarthria is typical.
 - E. There are no medications for the speech problem itself. Treatment consists of management of spasticity and tremor along with speech and language therapy (SLT)

- F. When to refer to SLT:
 - 1. Are problematic speech and voice characteristics detracting from the message being communicated?
 - 2. Are speech and voice adequate for daily communication?
 - 3. Are speech, voice, and communication problems interfering with the patient's quality of life?
 - 4. Are speech, voice, and communication problems perceived as troublesome by the patient and family?
- Dysphagia
 - A. Normal swallowing involves intricate and rapid coordination of sensory and motor activity in the oral cavity, pharynx, and esophagus.
 - B. Normal oromotor control for swallowing involves lip closure, facial tone and musculature, rotary lateral jaw motion, and pharyngeal swallow.
 - C. Due to MS, the following may occur:
 - 1. A delay in triggering the pharyngeal swallow
 - 2. Difficulty managing thin liquids
 - 3. Problems in the oromotor control phase
 - 4. Reduced tongue coordination
 - 5. Possible esophageal involvement
 - 6. Food aversions due to altered taste sensations
 - D. Assessment includes a careful history (pneumonia, difficulty with liquids and solids, aspiration or choking while eating).
 - E. Optimal management includes referral to a speech/language pathologist familiar with MS and its related problems.
 - F. Videofluoroscopic examination or modified barium swallow (MBS) may identify the patient's swallowing pathology. The resulting report should include a description of the patient's physiologic or anatomic swallowing abnormalies; any symptoms associated with the problem; results of any treatment attempted; and recommendations for treatment and dietary intake.
 - G. Treatment procedures involve:
 - 1. Changing the individual's head or body posture
 - 2. Controlling the volume and speed of eating
 - 3. Educating patients and families about voluntary swallowing maneuvers

- 4. Educating patients and families about fatigue and dysphagia with advice to rest during long meals and/or to eat more often for a shorter time
- Sexuality and intimacy
 - A. Primary sexual dysfunction occurs as a result of MS-related physiologic changes in the CNS that directly impact sexual feelings and/or response
 - B. Symptoms:
 - 1. Decreased or absent libido
 - 2. Altered genital sensations
 - 3. Decreased frequency, intensity of orgasms
 - 4. Erectile dysfunction
 - 5. Decreased vaginal lubrication/clitoral engorgement
 - 6. Decreased vaginal muscle tone
 - C. Management:
 - Men—pharmacologic management of erectile dysfunction (injections, Viagra[®])
 - 2. Women—medications (Viagra[®], lubrication, body mapping assessment)
 - D. Secondary sexual dysfunction occurs as a result of MS-related physical changes and treatments that indirectly affect sexual feelings and/or response
 - E. Etiology
 - 1. Bladder or bowel dysfunction
 - 2. Fatigue
 - 3. Non-genital sensory paresthesias
 - 4. Spasticity
 - 5. Cognitive impairment
 - 6. Tremor, pain
 - F. Management:
 - 1. Treat underlying symptoms
 - 2. Work with symptoms
 - ♦ positioning comfortably
 - ✤ using spasticity to maintain body contact
 - 3. Review and adjust medications
 - G. Tertiary sexual function is due to psychological, social, and cultural issues that interfere with sexual feelings and/or response. Origins are:

- 1. Clinical depression
- 2. Grief
- 3. Changes in self image and body image
- 4. Family and social role changes
- 5. Anger, guilt, depression
- 6. Spousal burden as caregiver
- H. Management:
 - 1. Counseling of patient and family
 - 2. Grief work
 - 3. Acknowledgment and treatment of intermittent problems
 - 4. Culturally sensitive interventions with appropriate support
- I. The nurse's role in working with sexuality and intimacy problems:
 - 1. Evaluate personal attitudes, values, and beliefs
 - 2. Assess personal knowledge
 - 3. Sustain comfort level in patient/partner interaction
- J. Some leading questions are:
 - 1. Has anything interfered with your ability to maintain closeness?
 - 2. How do you feel about being a man/woman?
 - 3. How has MS changed, if at all, your ability to function sexually?
- K. Some sexual assessment tools are:
 - 1. The Sexual Health Assessment Framework (Szasz, 1989)
 - ♦ sexual knowledge
 - \blacklozenge sexual self-view
 - ♦ sexual activity
 - ♦ sexual interest and behavior
 - ♦ sexual response
 - 2. PLISSIT Model
- L. Working with sexuality and intimacy
 - 1. Open, nonjudgmental atmosphere
 - 2. Ensure privacy
 - 3. Encourage open questions
 - 4. Normalize and validate concerns
 - 5. Part of the review of systems
 - 6. Offer resources and reassurance
- Cognition
 - A. The causes of cognitive changes may be divided into primary and secondary effects of the disease.

- B. Primary effects:
 - 1. The nerve cells themselves
 - 2. Lesions are multifocal and vary from person to person in distribution
 - 3. This may be explained by cerebral demyelination and axonal damage
- C. Secondary effects:
 - 1. Depression
 - 2. Anxiety
 - 3. Stress
 - 4. Fatigue
- D. Frequency, severity, and nature of cognitive changes
 - 1. Estimates range from 45 to 65% of people with MS having changes
 - 2. Only 10% suffer from severe impairment
 - 3. No correlation between disease course, disease severity, or length of time since diagnosis
 - 4. In most cases, cognitive dysfunction is characterized by selective impairment of some functions with relative preservation of others
 - 5. Cognitive functions thought to be affected:
 - ✦ memory (working memory and secondary memory)
 - ✤ abstract reasoning and problem solving
 - attention and concentration (especially sustained or complex attention)
 - ✦ speed of information processing
 - ♦ verbal fluency
- E. What is seen clinically?
 - 1. Inability to think
 - 2. Inability to remember
 - 3. Inability to reason logically
- F. The nurse role is:
 - 1. Establish a relationship with patients and families
 - 2. Facilitate communication
 - 3. Observe and assess
 - 4. Initiate referrals
 - 5. Promote coping strategies
 - 6. Monitor for safety

G. Impact of cognitive impairment:

- 1. Role strain
 - ✦ social roles
 - ♦ work roles
- H. Evaluation of cognitive impairment
 - 1. Informal evaluation
 - ♦ tool selection
 - nursing assessment
 - 2. Formal neuropsychological evaluation by neuropsychologists
 - ♦ patient selection
 - ♦ patient support
 - 3. Cognitive rehabilitation (mediocre results)
 - 4. Potential benefit from disease modifying agents
 - 5. Nursing interventions
 - ✤ recognizing and acknowledging deficits
 - ✦ accurate report of evaluation results
 - ✤ patient and family support
- Depression
 - A. Disorders of mood and affect
 - 1. Major depression (subsyndromal depression, suicide is 7.5% greater than general population)
 - 2. Bipolar affective disorder
 - 3. Euphoria
 - 4. Pathologic laughing and crying (mood swings)
 - B. Major depression
 - 1. Lifetime in approximately 50% with MS
 - 2. Point prevalence approximately 14%
 - 3. Increased compared to other neurologic disorders
 - C. Possible causes and contributors to depression in MS:
 - 1. Disease activity (especially exacerbations)
 - 2. Neuropathologic changes in areas of the brain concerned with affective states
 - 3. Neuroendocrine or psychoneuroimmunologic changes
 - 4. Reaction to altered life circumstances
 - 5. Medication side effects
 - D. Assessment of depression should be done on a regular basis.
 - E. Tools = CESD, Zung Depression Scale, or Beck Depression Inventory (preferred via consensus)

- F. Treatment of depression:
 - 1. Counseling and emotional support, psychotherapy
 - 2. Pharmacologic management
 - ✦ tricyclic antidepressants
 - ♦ mood stabilizing agents (Depakote[®], lithium carbonate)
 - ✦ SSRIs (fluoxetine, sertraline, paroxetine, venlafexine)
 - ✦ St. John's Wort (complementary or alternative medication [CAM])
 - ✦ support and therapeutic groups

Nursing care

- A. Empowers patients with knowledge and skills development
- B. Assists patients to make informed decisions
- C. Establishes an interdependent trusting relationship
- D. Encourages patients to share expectations, desires, and values
- E. Contributes to health-related quality of life (HRQOL) in MS
 - 1. HRQOL is a state of complete well-being and not merely the absence of disease/infirmity.
 - 2. It is degree of satisfaction with perceived present life circumstances.
 - 3. It is the perception of the impact of the disease both subjectively and objectively.
 - 4. It is a multidimensional construct emphasizing perceptions.
 - 5. MS has an effect on QOL through its array of symptomatology. Disease disruption ranges from mild to severe and may vary over time according to disease course and available supports.
 - 6. Specific issues related to MSQOL:
 - ✦ alterations in social environment
 - ✤ role reversals in family relationships
 - ✦ social and emotional isolation
 - ✤ misinterpretation of symptoms by others
 - ✦ restricted range of opportunities
 - ✦ alterations in body image
 - ✤ impact upon intimate relationships
 - 7. Roles of the nurse in MSQOL:
 - ✦ facilitating adjustment to MS
 - ✦ establishing a comfortable relationship
 - ✤ providing education and information
 - ✦ supporting, emphathizing, and "cheerleading"

- ✦ communicating, collaborating, and creating
- assisting with adjustment during the post-diagnosis period and throughout lifetime
- empowering patients through self-determination and self-advocacy
- ♦ simply being there when needed
- 8. Strategies to maintain MSQOL:
 - ◆ Encompass the patient's ability to:
 - ♦ adapt
 - ♦ communicate
 - ♦ socialize
 - ♦ be productive
 - ♦ Adapt
 - ♦ responding to change
 - \diamond identifying and evaluating options
 - \diamondsuit setting, resetting, and achieving flexible goals
 - ✦ Ability to communicate
 - ♦ developing and maintaining satisfying relationships
 - ♦ determining whether changes are needed in relationships
 - ♦ seeking supportive and reciprocal relationships
 - ♦ Ability to be productive
 - ♦ contributing to home work, school, or volunteer activities
 - \diamondsuit feeling that one's opinions matter to others
 - \diamond participating in meaningful activities
- 9. Significance when patients are cognitively impaired:
 - ✦ importance of selecting the right style of education
 - ✦ memory aids to help at home
 - ♦ frequent follow-up
 - ✦ reinforcement of actual expectations
 - ♦ ongoing education of patient/family
 - ♦ working with the MS team

Bladder Dysfunction

Objectives:

Upon completion of this chapter, the learner will:

- Describe the anatomy and physiology of the urinary tract
- Describe the neurologic innvervation of the urinary tract
- Describe diagnostic procedures used in the management of urinary dysfunction in MS
- Describe prevention and management of urinary dysfunction and MS
- Describe nursing interventions in bladder management in MS

Approximately 80% of patients with MS experience significant bladder dysfunction at some point in the course of disease. Bladder dysfunction causes alterations in personal, social, and vocational activities along with sleep disruption, embarrassment, dependency, and isolation. Nursing plays a major role in the assessment and treatment of bladder dysfunction and is designed to help the individual with MS achieve a predictable and effective elimination plan and to minimize complications.

Treatment goals

- A. Maintain renal function
- B. Keep patient dry
- C. Establish normal voiding patterns
- D. Reduce symptoms and improve quality of life
- E. Motivate patient to adhere to treatment
- Normal urinary function
 A. The kidneys of an adult female produce 100 to 125 ml per hour.

- B. Males produce closer to 150 ml per hour.
- C. The actual rate depends on fluid intake, position, and kidney function.
- D. Kidneys produce urine more efficiently in the supine position; thus, diuresis may become a problem for patients with heart or lung problems.
- E. Ureters are thin-walled muscular tubes that move urine from the kidneys to the bladder.
- F. Closure of the ureters during bladder contraction is accomplished by contraction of the trigone area during voiding.
- G. The main function of the urinary bladder is to store and expel urine.
- H. The bladder is a hollow muscular organ that is supported by loose connective tissue. The trigone and lower portion of the base of the bladder rest upon the anterior vaginal wall in women. The wall of the bladder consists of inner mucous membrane with a cell lining and underlying lamina propria; a layer of smoother muscle, the detrusor; and an outer layer of connective tissue.
- The urethra has an internal and external sphincter mechanism. The interior sphincter has three components (urethral mucosa, periurethral connective tissue, and periurethral vascular plexus). Each is responsible for one-third of the urethral closure pressure. The internal sphincter is composed of small muscle bundles and is not under voluntary control. The external sphincter is under voluntary control.
- J. The bladder is innervated by sympathetic fibers from the hypogastric nerve at T10 through L2 and parasympathetic fibers from the pelvic nerve at S2 through S4.
- K. As the bladder fills with urine, its fundus rises into the lower abdominal cavity.
- L. To initiate voiding, the urethra relaxes first, then the bladder contracts and expels the urine through the relaxed sphincter. These functions occur automatically.
- M.Average bladder capacity for an adult is 300 to 500 ml. The initial urge to void occurs when approximately 200 ml has accumulated. Contractions of the bladder are inhibited by the nervous system until 300 ml has been collected. An individual

can sense bladder fullness and can initiate or postpone emptying as convenient.

- N. Normally a person voids 4 to 6 times during a 24-hour period, depending on fluid intake, type, and amount.
- Problems occurring in MS
 - A. Bladder dysfunction in MS is primarily associated with demyelination in the spinal cord, the pontine cerebellar micturition control areas, or other CNS points in between.
 - B. Interruption of the spinal cord pathways may result in excessive detrusor contractions, involuntary sphincter relaxation or contraction, or detrusor areflexia with urinary retention.
 - C. Bladder dysfunction, or neurogenic bladder, may produce:
 - 1. *Urinary urgency*—a strong need to urinate that cannot be controlled or postponed
 - 2. *Urinary frequency*—the need to urinate more often than every 2 to 3 hours
 - 3. Urinary hesitancy—difficulty initiating the flow or urine
 - 4. *Nocturia*—waking up more than once during the night to urinate
 - 5. Incontinence—losing control of urine
 - 6. *Incomplete emptying*—feeling that some urine is left in the bladder after urinating
 - 7. *Urinary tract infections (UTIs)*—resulting in classic symptoms of burning or pain upon urination. This may result in a temporary worsening of MS symptoms or may be the first sign that a person is experiencing a change in usual bladder function.
 - D. The presence of one or more of these symptoms is suggestive of a neurogenic bladder.
 - E. The three common types of bladder dysfunction are the result of:
 - 1. Hypercontractility of the detrusor muscle
 - 2. Inability of the sphincter to relax and open, or detrusor areflexia
 - 3. Incoordination of the detrusor and sphincter activity: detrusorsphincter dyssynergia (DSD)
 - F. In summary, bladder dysfunction in MS can result in failure to store urine, failure to empty urine, or combined dysfunction.
 - G. Similar symptoms may be present in all three types of bladder dysfunction.

Assessment of bladder dysfunction

- A. Evaluation of patient's chief concern
- B. Voiding pattern, daytime and nighttime
- C. History of incontinent episodes
- D. Urinary patterns and symptoms—urgency, frequency, incontinence, hesitancy, hematuria, use of protective pads, dysuria, UTIs
- E. Medical history—surgery, number of full-term pregnancies, gynecologic problems
- F. Current medications
- G. Evaluation of post-void residual via straight catheterization or bladder ultrasound.
 - 1. In straight catheterization patient drinks two 8-ounce glasses of water prior to assessment.
 - ◆ patient voids and output is measured.
 - ♦ patient is catheterized for post-void residual urine.
 - ♦ greater than 100 ml, the patient requires instruction in self-catheterization
 - frequency of self-catheterization depends on amount of urine remaining in the bladder after voiding.
 - ♦ if there is 100 ml in the bladder, can be done once daily♦ if more than 200 ml, twice daily
 - ✦ If residual is less than 60 ml, patient is prescribed medications to control/reduce bladder spasms and promote more efficient bladder storage of urine
- H. Bladder ultrasound
 - 1. Full bladder is scanned for total volume of urine in bladder
 - 2. Patient then voids
 - 3. Bladder is rescanned to determine post-void residual
- I. Follow-up is the same as above.
- J. With intermittent self-catherization in the failure-to-empty bladder, the addition of anticholinergic or antimuscarinic medication may be considered to reduce patient's symptoms despite fully emptying of the bladder.
- Additional studies:
 - A. Kidney and bladder ultrasound can yield information about structural abnormalities causing symptoms
 - B. Intravenous pyelogram (IVP) can outline the ureters and is also a test of kidney function.

- C. Urodynamic studies clarify the function of the muscles of the lower urinary tract. Complete urodynamic testing includes uroflowmetry, the quantitative and qualitative analysis of urinary stream. It is the measurement of the rate of urination and force of the bladder's expulsive ability.
- D. Pressure flow parameters in the study include bladder pressure, rectal pressure, differential pressure, urethral pressure, flow rate, volume, and electromyogram (EMG) sphincter activity.
- E. Both needle and surface EMG and CMG (filling cystometrogram) are helpful in diagnosing detrusor-sphincter dyssynergia.
- Bladder management interventions:
 - A. Bladder training consists of education, scheduled voiding, and positive reinforcement. This requires that the participant resist or inhibit the sensation of urgency to postpone voiding, and urinate according to a timetable rather than according to the urge to void.
 - B. Bladder training may also involve tactics to allow the bladder to hold a greater volume:
 - 1. Drinking an adequate amount of fluid at one sitting will generally result in an urge to void within the retraining time frame.
 - 2. Avoiding fluids with caffeine, artificial sweeteners, and alcohol will reduce bladder irritability.
 - 3. Protective pads may absorb involuntary urine outflow.
 - 4. Male external catheters may help do the same.
 - 5. Medications that are beneficial for failure to store and DSD include:
 - ✦ anticholinergics (oxybutynin)
 - ✦ antimuscarinics (tolterodine tartrate, hyoscyamine sulfate)
 - tricyclic antidepressants (imipramine)
 - antidiuretic hormone analog (desmopressin acetate), particularly for nocturia
 - C. Crede method is contraindicated because of the potential to create increased pressure and damage the upper tract.
 - D. Intermittent self-catheterization (ISC)
 - 1. Allows an individual to empty the bladder at regular intervals, thereby reducing the risk of UTI, structural damage, and other distressing bladder symptoms.
 - 2. This technique has been widely supported in the literature. It uses a clean technique. Teaching guides are available

- E. An indwelling catheter may be needed for either short- or long-term use and allows for continual drainage by gravity.
 - 1. Its use is suggested for those individuals who cannot be managed with ISC and/or medications, or who have chronic decubiti and cannot perform ISC.
 - 2. Long-term use of indwelling catheters is a significant source of bacteruria and UTI. Management varies but the usual practice is to change the catheter after a minimum of 30 days or prn. If the patient has a symptomatic UTI, the entire system must be changed and a urine culture obtained.
 - 3. A person with MS may still experience urinary incontinence with an indwelling catheter. In this instance, the indication is not to increase the size of the catheter or balloon, but rather to use anticholinergic/antimuscarinic medications to decrease urinary tract spasticity.
- Surgical interventions:
 - A. Suprapubic catheters are sometimes an alternative to long-term urethral catheters. These may be helpful in male patients and in women who have developed severe urethral irritation secondary to an indwelling Foley catheter.
 - B. Sphincterectomy may be recommended for very disabled male patients who experience intractable hesitancy and retention. Anticholinergic medications and an external condom catheter can be combined to manage bladder activity.
 - C. Some female patients with small-capacity bladder may benefit from a laparoscopic procedure that includes bladder augmentation with a continent diversion. Patients then can catheterize a stoma at the navel or abdomen.
 - D. Diversion procedures including cystostomy or transurethral resection, which provides a clear passageway for the urine to flow freely. This procedure is used only rarely.

Bowel Elimination and Continence

Objectives:

Upon completion of this chapter, the learner will identify:

- The common pathophysiology of upper motor neuron bowel, lower motor neuron bowel, uninhibited neurogenic bowel, and motor paralytic bowel as seen in MS
- ◆ Goals for establishing bowel control with MS
- Common nursing interventions in managing a neurogenic bowel
- ◆ A comprehensive care plan for gastrointestinal complications
- ◆ The long-term implications of neurogenic bowel dysfunction

Altered bowel function may occur whenever the central nervous system (CNS) has been impaired. When disease or disability results in altered bowel control, incontinence may become as devastating a problem as the disease itself. Control of incontinence and prevention of constipation and diarrhea are possible through an effective bowel program, which requires a knowledge of normal and altered bowel physiology as well as an in-depth assessment of bowel function.

- Normal bowel anatomy and physiology
 - A. The lower bowel acts under voluntary control to store and eliminate feces.
 - B. Inability to store fecal matter causes problems with involuntary bowel or incontinence.
 - C. Inability to eliminate causes constipation.
 - D. The bowel consists of three separate parts: the ileum, the cecum, and the colon.

- E. The *ileum* is approximately the last third of the small intestine.
 - 1. It is approximately 12 feet long and extends from the jejunum to the ileocecal opening.
 - 2. Almost all absorption and digestion is accomplished in the small intestine.
 - 3. The small intestine absorbs water and sodium and secretes mucus, potassium, and bicarbonate for stool formation.
- F. The *cecum* is 6 cm in length and lies below the terminal ileum, forming the first part of the large intestine.
- G. The *colon* is the division of the large intestine that extends from the cecum to the rectum.
 - 1. In the colon, fluids and electrolytes are reabsorbed and feces are stored so that defecation can occur at an acceptable time.
 - 2. Defecation is affected by peristalsis, anorectal sensory awareness, anal sphincter function, and abdominal muscle function and strength.
- H. The *rectum* is the 12 cm segment of the large bowel between the sigmoid colon and the anal canal. As a rule, it does not contain feces except during defecation.
- I. The *anal canal* comprises the last 3 cm of the digestive tubes. Striated muscle in the anal canal and pelvic floor provides support to the rectal wall and anus, thus maintaining continence.
- Neurogenic bowel
 - A. Constipation:
 - 1. Neurogenic bowel results from the interruption of neural pathways that supply the rectum, external sphincter, and accessory muscles involved in defecation.
 - 2. Nerve impulses that are disrupted may impede cerebral recognition of anal contents and the need to empty stool at a desired or planned time.
 - 3. Slowed transit may result in constipation.
 - 4. Weakened abdominal muscles may make bearing down very difficult.
 - 5. Decreased activity related to altered mobility, fatigue, or a sedentary lifestyle may contribute to slow bowel function.
 - 6. Constipation has been defined as less than or equal to two bowel movements per week; or the need for stimulation, the use of laxatives, enemas, or suppositories more than once a week.

- 7. Constipation has also been characterized by hard, dry stool, causing straining or painful defecation and resulting in a delay of passage of food residue.
- 8. Medications contributing to constipation may include
 - ♦ analgesics
 - ♦ anticholinergics
 - ♦ anticonvulsants
 - \blacklozenge antidepressants
 - ♦ diuretics
 - ♦ psychotherapeutics
 - ♦ iron
 - ♦ opiates
 - ♦ muscle relaxants
- 9. Other neurologic factors that contribute to neurogenic bowel conditions:
 - ✦ lack of exercise
 - ♦ inadequate fluid intake
 - ♦ inadequate dietary fiber
 - ♦ effects of medication
- 10. Diarrhea may result from gastrointestinal influenza, dietary irritants, and gastrointestinal disorders.
- B. Diarrhea or involuntary bowel:
 - 1. Diarrhea (loose, liquid stools) and frequent discharge of fluid fecal matter may be secondary to
 - \blacklozenge fecal impaction
 - ✦ diet or irritating foods
 - \blacklozenge inflammation or irritation of the bowel
 - ♦ stress, anxiety
 - ✦ medications
 - \blacklozenge overuse of laxatives or stool softeners
 - ✦ dietary intolerance of milk products, chocolate
 - 2. Diarrhea may be accompanied by urgency, cramping, abdominal pain, increased bowel sounds, or increased volume of stools.
 - 3. In MS, involuntary bowel or fecal incontinence is the result of interruption in the neural pathways and impaired cortical awareness of the urge to defecate.
 - ♦ characterized by urgency and involuntary stools

- ✦ defecation is sudden with or without urgency
- patient may also experience partial or total sensory loss in the perineum and rectum
- Assessment and management of bowel function/dysfunction
 - A. Questions to ask include the use of medications that influence bowel activity, such as diuretics, antacids, nonsteroidal anti-inflammatory agents, anticholinergics, antidepressants, antibiotics, laxatives, and enemas.
 - 1. Presence or absence of the awareness of the need to defecate.
 - 2. Frequency and quality of stool including color and consistency.
 - 3. Fluid and dietary history should include fluid intake, daily intake of fiber, and type of food or snacks eaten.
 - 4. Objective assessment of the abdomen should include auscultation, palpation, and percussion.
 - 5. Assessment should include patient's functional ability to ambulate and transfer, the use of assistive devices, the ability to remove clothing, and the accessibility of toilet facilities.
 - B. Interventions to manage bowel dysfunction:
 - 1. Goals of bowel training program include:
 - ✦ normalizing stool consistency
 - ◆ establishing a regular pattern for defecation
 - ✦ stimulating rectal emptying on a routine basis
 - avoiding complications of diarrhea, constipation, or incontinence
 - ✦ improving the patient's quality of life
 - C. Constipation should be first treated with nonpharmacologic interventions:
 - 1. Increased fluid intake (1 to 2 quarts daily), fiber, exercise.
 - 2. Education and support are equally important.
 - 3. Establish a regular pattern of bowel elimination.
 - 4. Use the gastrocolic reflex.
 - 5. Sit in an upright position with feet on the floor.
 - 6. The program may take 3 to 4 weeks or longer.
 - 7. The use of stool softeners or bulk formers with fluids and fiber may help.
 - 8. Oral stimulants provide a chemical stimulation and a localized mechanical stimulation and lubrication to promote elimination of stool.

- 9. Glycerin suppositories provide lubrication for passage of stool.
- 10. Dulcolax[®] suppositories and Therevac[®] mini enemas contain medications that stimulate strong, involuntary, wavelike movement that facilitates the elimination of stool.
- 11. Regular use of enemas should be avoided to minimize the risk of dependency.
- 12. Fecal impaction is a complication of chronic constipation: manual disimpaction or soap suds enemas are the options for immediate treatment, but long-term management with the above is the appropriate option.
- 13. An episode of fecal impaction is an indication for the need for an aggressive bowel program.
- D. Fecal incontinence:
 - 1. Adequate bulk and fiber is important for maintenance of stool consistency. Patients should be instructed to avoid overly spicy and gas-forming foods.
 - 2. Planned times for bowel evacuation and the use of suppositories to stimulate rectal emptying allows for more bowel control.
 - 3. Establishing a routine eliminates involuntary bowel accidents.
 - 4. Encourage the patient to sit on a toilet or commode for 25 to 30 minutes after consuming a hot beverage.
 - 5. The following strategies may help:
 - ♦ sit comfortably on the toilet and try to "bear down"
 - rocking back and forth and massaging the abdomen can promote bowel activity
 - ★ if the bowels do not move within 10 minutes, leave the bathroom and try again later when another "urge" is present
- E. Expected outcomes of bowel management:
 - 1. Predictable, regular bowel evacuation.
 - 2. Decrease in episodes of constipation or involuntary bowel.
 - 3. Formed stool.
 - 4. Avoidance of prescription drugs, strong laxatives, or enemas.
 - 5. Patient and family awareness of the elements of bowel management.
 - 6. Patient and family awareness of early signs of bowel dysfunction.

The Nurse's Role in Advanced Multiple Sclerosis

Objectives:

Upon completion of this chapter, the learner will:

- ◆ Describe key issues of concern in advanced MS
- Discuss nursing implications in progressive disease
- Cite specific strategies in avoiding complications of this advanced condition
- Advanced MS
 - A. A small percentage (5%) of people with MS become severely disabled
 - B. Caregivers are faced with ongoing tasks and special needs in this population
 - C. The nurse is challenged as both a caregiver and educator of the patient, family, and responsible others in the patient's life

Nutrition

- A. General nutrition
 - 1. A well-balanced diet is important throughout one's lifetime—sick or well.
 - 2. Good nutrition is characterized by a well-developed body with ideal weight, healthy hair and skin, and mental alertness.
 - 3. RDA recommendation by the U.S. Department of Agriculture are guidelines for health professionals and patients.
 - 4. Recommendations include servings in bread and cereal group, vegetable and fruit groups, limiting fat intake, and adequate intake of water and fluids.
 - 5. There is no conclusive evidence that any nutritional therapy affects the course of MS.

- 6. The nurse is in an excellent position to educate patients and families about nutrition.
- B. MS factors that can affect nutrition
 - 1. Tremor, weakness, paralysis, and dysphagia can interfere with nutrition.
 - 2. Fatigue and depression may alter nutritional status.
- C. Managing nutritional problems:
 - 1. Patient's weight should be monitored.
 - 2. A swallowing evaluation should be recommended when indicated.
 - 3. A registered dietitian can determine caloric needs based on activity level.
 - 4. A person with skin breakdown will need increased calories and protein to promote healing.
 - 5. Feeding techniques and education may be required in a person with dysphagia.
 - 6. Referrals to home health programs to relieve the caregiver may be necessary.
 - 7. Meals-on-wheels or food stamps may be helpful.
 - 8. Those with decreased energy may precook or microwave meals.
 - 9. Small, frequent feedings may be recommended.
 - 10. Adaptive equipment such as weighted utensils, elongated straws, and modified dishes may be helpful.
 - 11. Nutritional supplements may ensure adequate intake in patients with fatigue.
 - 12. Fluid intake in advanced MS:
 - minimum of 8 glasses needed daily (1500–2000 ml/24 hours)
 - ◆ UTIs can be reduced with acidification and hydration
 - ✦ fluids can be obtained through gelatin and other desserts
 - ♦ supplemental tube feedings may be necessary
- Urinary tract infections (UTIs)
 - A. UTIs pose a serious threat in advanced MS.
 - B. Urinary drainage may be accomplished through spontaneous voiding, IC, or indwelling catheter.
 - C. While IC is the preferred artificial way of emptying the bladder, indwelling catheters are a reality in advanced disease.

- D. Attention must be given to keep tubing and drainage bags as clean as possible.
- E. Catheters should be changed regularly.
- F. Patients must be monitored for signs and symptoms of UTI (fever, U/A, C&S, increased spasticity, etc.)
- G. Treatment of UTIs (symptomatic vs. colonized) should be initiated promptly.
- Spasticity
 - A. Management is a challenge because of intercurrent symptoms such as fatigue and weakness.
 - B. Medications consist of baclofen, tizanidine, dantrolene, diazepam, and gabapentin.
 - C. Stretching, positioning, and ROM are important to maintain muscle length and tone.
 - D. Blocks and surgical techniques may be beneficial.
 - E. The advent of intrathecal delivery of baclofen is a breakthrough in the management of intractable spasticity.
 - F. Pump maintenance and dose titration are relatively simple.

Skin care

- A. Prevention of skin breakdown is essential.
- B. Braden and Norton Scales have been validated in MS.
- C. Braces or splints may cause friction or pressure.
- D. Maintenance of desired weight is important.
- E. Nursing activities include:
 - 1. Identification of predisposing factors
 - 2. Patient and family education
 - 3. Use of appropriate assistive devices for transfers
 - 4. Regular skin inspection
 - 5. Maintenance of bowel and bladder continence
 - 6. Adequate personal hygiene
 - 7. Adequate nutrition and fluid intake
- Personal care
 - A. Formal and informal caregivers may be required.
 - B. Respite care is important to prevent burnout.
 - C. Alternative long-term solutions may need to be explored.
 - D. Day treatment programs may relieve caregiver burden.
- Family needs
 - A. Advanced directives should be discussed.

- B. Life planning should be encouraged.
- C. Counseling and education are essential to support family needs.
- D. Community agencies are important assets at this time.
- E. Opportunities to communicate fears and concerns are important.

Primary Care Needs

Objectives:

Upon completion of this chapter, the learner will:

- Describe the importance of the maintenance of a balanced health state
- Discuss primary care needs in MS
- ◆ Cite specific wellness activities in MS for men and women
- Annual physical examinations are essential for men and women with MS.
- They should include:
 - A. Blood work (CBC, comprehensive profile, thyroid function tests)
 - B. Height and weight if possible
 - C. Blood pressure
 - D. Assessment for risk factors (osteoporosis, diabetes, etc.)
 - E. Education regarding exercise, smoking, diet, etc.
- Hormonally mediated events
 - A. Pregnancy (there is a 70% reduction in risk of exacerbation during pregnancy and a 70% increase the 3 to 8 months postpartum)
 - 1. Education should include assessment of:
 - ✤ The patient's capabilities before conception
 - ◆ Available supports for the postpartum period
 - Considerations regarding breast feeding versus bottle feeding, issues of fatigue, DMAs
 - ✤ The family's living situation and economic resources

- Menstrual cycle assessment should include normal cycle, premenstrual syndrome, cramping, bloating, current medications.
- Menopause—there is a paucity of research in this area. Current information about hormone replacement therapy (HRT) is confusing regarding risk reduction for osteoporosis and for coronary heart disease (CHD) and osteoporosis. Consultation with a gynecologist may be recommended.
- Recognizing and preventing pseudoexacerbations should include the following caveats:
 - A. Avoid increasing core body temperature (fever).
 - B. Maintain body coolness with cooling devices, cool drinks, and cool showers if ambient temperature is high.
 - C. Cool down frequently when exercising, and exercise in a cool environment.
 - D. Treat infections promptly.

Osteoporosis

- A. May occur in both men and women with MS
- B. Is associated with reduced mobility and use of corticosteroids
- C. Falls may result in fractures and increased disability
- D. Assessment should include bone density study (DXA); a *z*-score of less than –2.0 requires treatment

- 8. Conclusion—preventing bone loss and vertebral fractures can be attained to some degree with any of the currently approved medications, exercise, and possibly diet. A person who has sustained a fracture is certainly a candidate for pharmacologic therapy.
- Pulmonary complications
 - A. Pulmonary dysfunction secondary to MS is a leading cause of morbidity and mortality in MS.
 - B. Assessment should include history of pneumonia, aspiration, dypnea, weak cough, hypophonia, and fatigue.

- Definition of terms
 - A. Protocol-a framework for the conduct of the study.
 - B. *Investigator's brochure*—a detailed, confidential description of the structure and formulation of the drug, and a summary of the studies and adverse events.
 - C. 1572—the official document that secures the investigator's commitment to conduct the study within FDA guidelines.
 - D. *Source documents*—documents that contain all the clinical information gathered during a visit.
 - E. *Case report forms*—concise information reflective of the source documents entered into duplicate forms that are collected and returned to the sponsor for data entry.
- Trial design
 - A. *Open label*—the investigators and patients are aware of what drug or treatment is being tested.
 - B. *Single-blinded study*—the patient is blinded to the treatment but the investigator is aware of what is being tested.
 - C. *Double-blinded study*—neither the investigator nor the patient knows who has been randomly assigned to what treatment (active therapy or placebo).
 - D. *Cross-over study*—participants receive either placebo or tested therapy over a specific time, then investigational drug for the remainder of the study.
- Institutional Review Board (IRB) determines that:
 - A. Risks to subjects are minimized.
 - B. Risks to subjects are reasonable in relation to anticipated benefits.
 - C. Selection of subjects is equitable.

- D. Informed consent is obtained from the subjects or from a legal representative.
- E. The research has a rational scientific basis, as does the methodology.
- F. The research plan makes adequate provision for monitoring the data to ensure the safety of subjects.
- G. There are adequate provisions to protect the privacy of the subject.
- Informed consent is based on ethical principles of full disclosure and the right of self-determination. The consent must be easily understood by a lay person and must contain the following:

 - B. An explanation of the purpose of the research, the design or the study, and procedures that are experimental
 - C. A description of any foreseeable risks or discomforts including, for women who are able to have children, risks to childbearing or to the fetus.
 - D.A description of potential benefits
 - E. A disclosure of appropriate alternative procedures or course of treatment, if any, that may be advantageous to the subject
 - F. A statement describing the extent to which confidentiality of records will be maintained, including the fact that the FDA might inspect the records
 - G. For research involving more than a minimal risk, an explanation as to whether compensation and medical treatments are available
 - H.An explanation of who should be contacted for answers to pertinent questions about the research and the research subject's rights
 - I. A statement that participation is voluntary, refusal to participate will not result in any penalty or loss of service to which the subject is otherwise entitled, and that the subject may withdraw at any time without penalty
- Adverse events
 - A. *Adverse drug experience*—any unfavorable and unintended sign, symptom, or disease temporally associated with the use of investigational product
 - B. *Serious adverse drug experience*—any experience that results in death, a life-threatening adverse event, inpatient hospitalization

or prolongation of hospitalization, a persistent or significant disability or incapacity related to the research

- C. Unexpected adverse drug experience—any adverse experience, the specificity or severity of which is not consistent with the current investigator's brochure
- Nursing assessment
 - A. How realistic are the patient's expectations of what the drug under study will and will not do for MS?
 - B. Does the person understand that there might be a chance of receiving a placebo (in placebo-controlled studies)?
 - C. Is the patient committed to the frequency of visits, testing requirements, and procedures outlined in the consent form and protocol?
 - D. How successful has the patient been in the past in terms of keeping appointments and adhering to treatments?
 - E. Does the patient lack adequate insurance for currently available treatments?
 - F. Is the patient experiencing a decline in functional status despite aggressive therapeutic interventions?
- Recommendations for research nurse coordinators:
 - A. A study has a beginning, middle, and end; there will be closure.
 - B. Study work will satisfy a compulsive edge, if you have one.
 - C. Keep in touch with other nurse coordinators for support and information.
 - D. Take care of yourself; this is hard work.
 - E. Participate in the investigators' meeting; this is your opportunity to share experiences with others and with the sponsor.
 - F. Think of research questions you may want to incorporate into the study; sponsors often are interested in other research questions.

Case Studies

Case Study 1

Sally is thirty-four years old and was diagnosed with MS in 1992. She initially experienced a relapsing-remitting course in which her exacerbations were mild and occurred infrequently. After her second pregnancy, about 6 months postpartum, she had a severe exacerbation that resulted in paralysis of both lower extremities. Following hospitalization for intravenous steroids, she was treated in an inpatient rehabilitation hospital for strengthening and improvement of function. When she was discharged, she was able to walk with a wheeled walker and she used a motorized tricart for longer distances.

Her ability to walk has diminished, she is able to stand and pivot for transfers, and only take a few steps to and from chairs and her bed. She continues to experience attacks of her MS and, despite treatment with steroids, she has had incomplete recovery (secondary progressive MS). She requires maximal assistance to get in and out of her car. She uses a tub transfer chair to bathe and grab bars to get up and down from her commode. She uses a long-handled reacher in her kitchen and bedroom to reach items on high shelves. She has had a ramp installed at her front door and has widened the doorways in her home to accommodate her scooter. She is subject to fatigue and finds that if she rests in the afternoons, she is able to stay up until 9 or 10 PM before going to bed.

Sally and her family have had frequent contact with the National Multiple Sclerosis Society (NMSS), participating in several educational programs, family weekends, and support groups. Sally receives her care at an MS Center where, in addition to neurologic care, she has had nursing care for bladder and bowel management, counseling to assist her to adjust to her changing physical condition, and rehabilitation services. She has had physical therapy for mobility and to develop a home program, and occupational therapy for upper extrem-

ity function and the appropriate use of assistive devices. Her current medications consist of Ditropan[®] and Hiprex[®] for her bladder, Cylert[®] for fatigue, and Neurontin[®] for pain.
